

EDGEWELL'S e-MOVIE CASH OFFER

TERMS AND CONDITIONS

1. OFFER PERIOD:

The Edgewell (Hydro 5 and Edge) and Transformers: The Last Knight e-Movie Cash Offer (the "Offer") begins in brick and mortar/physical stores (offer not available for purchases made on-line or otherwise outside a brick and mortar/physical store) on June 4, 2017 and ends on June 24, 2017 (the "Offer Period").

2. ELIGIBILITY:

Offer is open to residents of the 50 United States, and the District of Columbia, except employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of Edgewell Personal Care Brands, LLC (the "Sponsor"), TPG Rewards Inc. ("TPG"), Paramount Pictures Corporation, Walgreen Co., their respective parent companies, subsidiaries, affiliates, reward suppliers, advertising/promotion agencies and any entity involved in the development, production, implementation, administration, or fulfillment of the Offer (collectively, the "Released Parties").

INTERNET ACCESS AND PRINTER REQUIRED FOR PARTICIPATION IN OFFER.

3. HOW TO RECEIVE YOUR e-MOVIE CASH® TICKET:

To receive your e-Movie Cash, you must:

- (a) Purchase \$15.00 or more of qualifying Schick and/or Edge Men's Shave products in a single transaction at a participating Walgreens and Duane Reade store (see Attachment A for list of participating products). The \$15.00 total can be achieved with the purchase of a single item having a retail price (regardless of whether consumer uses coupon/discount in conjunction with such purchase) of \$15.00 or more, or the purchase of two or more qualifying items, totaling a combined retail price (regardless of whether consumer uses coupon/discount in conjunction with such purchase) of \$15.00 or more in a single transaction made between June 4, 2017 and June 24, 2017. - (c) Send the photo of the receipt via email or text message to hydrobot@uploadreceipt.com or upload to www.HydroBotmovienight.com by no later than July 15, 2017, 11:59:59 PM PACIFIC TIME (PT). Do NOT submit photo of the receipt via more than one (1) method. - (d) If submitting photo via email or text message, approximately 60 minutes after submission, you will receive a reply via email or text ** (depending on the format used to submit photo of receipt). If your submission is validated, you will receive in the return email/text a unique PIN code and instructions on how to receive your Offer. - (e) Go to www.HydroBotmovienight.com/redeem and follow the on-screen instructions, which includes entering in the required information including your unique PIN code and email address in order to receive the e-Movie Cash ticket (value of up to a maximum of \$10.00). The on-screen instructions are made a part of these Terms and incorporated herein by reference. PIN codes must be entered at website by no later than July 31, 2017, 11:59:59 PM PT.
- (f) The maximum number of PIN codes/e-Movie Cash Tickets a consumer can receive from a single receipt submission/qualifying purchase is one (1). The maximum number of PIN codes/e-Movie Cash Tickets allowed per person, household, email address or phone number, throughout the Offer is two (2).
- (g) e-Movie Cash tickets may be redeemed for any movie, any day or time, at any participating U.S. theater, subject to e-Movie Cash ticket usage restrictions (see Section 7 below). e-Movie Cash tickets expire August 31, 2017, 11:59:59 PM EASTERN TIME (ET). For the avoidance of doubt, e-Movie Cash ticket need not be redeemed to see Transformers: The Last Knight.
